**RESOLUTION CHANGING THE TIME OF  
THE FORSYTH COUNTY BOARD OF  
COMMISSIONERS' REGULAR MEETINGS  
BEGINNING OCTOBER 10, 2016**

**WHEREAS**, the Forsyth County Board of Commissioners proposes to change the time of its regular Board meetings from 6:00 p.m. to 2:00 p.m. beginning Monday, October 10, 2016; and

**WHEREAS**, N.C.G.S. 153A-40 authorizes the Forsyth County Board of Commissioners to adopt a resolution fixing the time of its regular meetings and further requires a copy of such a resolution, after its adoption, to be posted on the courthouse bulletin board and a summary of it to be published at least ten (10) days before the first meeting to which the resolution is to apply; and

**WHEREAS**, in addition to the posting and publication requirements of N.C.G.S. 153A-40, the Forsyth County Board of Commissioners will also cause this Resolution, after its adoption, to be posted on the bulletin boards located outside the Commissioners' meeting room on the fifth floor and in the lobby on the first floor of the Forsyth County Government Center; and

**WHEREAS**, N.C.G.S. 143-318.12 requires the revised schedule to be filed with the Clerk to the Board of County Commissioners for at least seven (7) calendar days before the day of the first meeting held pursuant to the revised schedule and to post the schedule of regular meetings to the County's Web Site.

**NOW, THEREFORE, BE IT RESOLVED**, that the Forsyth County Board of Commissioners hereby changes the time of its regular Board meetings from 6:00 p.m. to 2:00 p.m. beginning Monday, October 10, 2016 after the Board has complied with the provisions of N.C.G.S. 153A-40 and N.C.G.S. 143-318.12 for posting and publishing this Resolution and the additional posting as provided herein.

**BE IT FURTHER RESOLVED** that the regular meetings of the Forsyth County Board of Commissioners, will continue to be held on the second and fourth Mondays of each month in the Commissioners' Meeting Room on the fifth floor of the Forsyth County Government Center located at 201 N. Chestnut Street, Winston-Salem, North Carolina.
