ORDER CLOSING A PORTION OF NO NAME 6 ROAD

WHEREAS, a Petition was filed on the 6<sup>th</sup> day of October, 2016, with the Forsyth County Board of Commissioners, pursuant to N.C.G.S. 153A-241 to close a portion of No Name 6 Road as hereinbelow described; and

WHEREAS, on the 14<sup>th</sup> day of November, 2016, at a regular meeting of the Forsyth County Board of Commissioners, a resolution fixing the date and hour for a public hearing on said petition and declaring intent to close was adopted by unanimous vote of said Board of Commissioners; and the date and hour were fixed as the 9<sup>th</sup> day of January, 2017 at 2:00 P.M., in the Commissioners' Meeting Room of the Forsyth County Government Center, in the City of Winston-Salem, North Carolina; and

WHEREAS, notice of the Board's intent to close and scheduled public hearing was published once a week for three successive weeks in the Winston-Salem Journal, a newspaper of general circulation published in the City of Winston-Salem, North Carolina, and notice of the proposed closing and public hearing was posted in at least two prominent places along said portion of No Name 6 Road for 28 days preceding the final hearing; and notice was also mailed to abutting owners all as required by law and stated in the Resolution Declaring The Forsyth County Board Of Commissioners' Intent To Close A Portion Of No Name 6 Road And Calling A Date For Public Hearing On The Matter; and

WHEREAS, ownership of abutting or adjoining property is as follows:

WHEREAS, at a meeting of the Forsyth County Board of Commissioners held on the 9<sup>th</sup> day of January, 2017, a public hearing was held on the petition to close a portion of No Name 6 Road; and

WHEREAS, it appears to the satisfaction of the Forsyth County Board of Commissioners, that the closing of said portion of No Name 6 Road is not contrary to the public interest and that no individual owning property adjoining, abutting or in the vicinity of said street or road will thereby be deprived of reasonable means of ingress and egress to his property; and

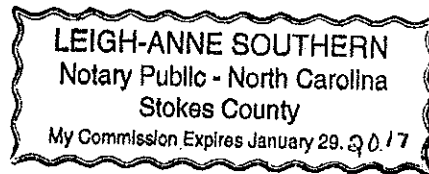

## **RESOLUTION**

### **DECLARING THE FORSYTH COUNTY BOARD OF COMMISSIONERS' INTENT TO CLOSE A PORTION OF NO NAME 6 ROAD AND CALLING A DATE FOR PUBLIC HEARING ON THE MATTER**

**WHEREAS**, on October 6, 2016, a Petition was filed with the Forsyth County Board of Commissioners on behalf of Petitioner, Steve Plemmons requesting the closing of a portion of No Name 6 Road, hereinafter described, which property is lying and being within the county limits of Forsyth County; and It appearing to the Forsyth County Board of Commissioners from said Petition that a public hearing should be held on the question of closing the portion of No Name 6 Road, pursuant to authority conferred upon counties by the provisions of N.C.G.S. 153A-241; and **WHEREAS**, the Planning and Development Services Department reports that the subject road, No Name 6 Road, has never been maintained by North Carolina Department of Transportation, therefore, no abandonment of maintenance is required; and **WHEREAS**, the Planning and Development Services Department concludes that there would be no negative impacts from the right-of-way being closed since all of the affected properties are owned by the Petitioner; and **WHEREAS**, based on said Petition to Close a Portion of No Name 6 Road and the above Planning staff findings, the Forsyth County Board of Commissioners will declare herein its intent to close said portion of No Name 6 Road; and **WHEREAS**, the Forsyth County Board of Commissioners will call a public hearing on the Petition to Close a Portion of No Name 6 Road, nothing else appearing for Monday, January 9, 2017 at 2:00 p.m. in the Commissioners' Meeting Room on the fifth floor of the Forsyth County Government Center; and **WHEREAS**, pursuant to the provisions of N.C.G.S. 153A-241, the Forsyth County Board of Commissioners will direct the Petitioner to cause notice of the public hearing reasonably calculated to give full and fair disclosure of the proposed road closing to be published once a week for three successive weeks before the hearing date, a copy of this Resolution to be sent by registered or certified mail to each owner as shown on the county tax records of property adjoining the affected portion of the public road who did not join in the Petition to Close a Portion of No Name 6 Road, and a notice of the closing and public hearing to be

prominently posted in at least two places along the said portion of No Name 6 Road;

**NOW, THEREFORE, BE IT RESOLVED**, by the Forsyth County Board of Commissioners as follows:

- (1)** That the Board of Commissioners hereby declares its intent to close said portion of the No Name 6 Road as described in and pursuant to the provisions of the attached Petition to Close;
- (2)** That the date and hour fixed for a public hearing on said Petition to Close a Portion of No Name 6 Road is hereby set for Monday, January 9, 2017, at 2:00 p.m., in the Commissioners' Meeting Room on the fifth floor of the Forsyth County Government Center at 201 N. Chestnut Street in Winston-Salem, North Carolina;
- (3)** That all persons who are interested in the closing of the portion of No Name 6 Road and desiring to be heard, are hereby notified to appear before the Forsyth County Board of Commissioners, at the above-scheduled public hearing, at which time and place they will be heard in favor of or in opposition to the adoption of a resolution ordering the closing of the portion of No Name 6 Road described as follows: Being that portion of the designated "30 FT DRIVE" lying west of and adjacent to Lot Nos. 30, 31, 32, 33, 34, 35, 36, 37, 38 and 39 as depicted on a plat entitled "Map of the G.T. Baker Place" recorded in Plat Book 10 Page 166 of the Forsyth County Register of Deeds Office;
- (4)** That the Petitioner be and is hereby directed to send a copy of this Resolution by registered or certified mail to each owner, as shown on the County tax records of property adjoining the said portion of No Name 6 Road to be closed, who did not join in the request to have the said portion of No Name 6 Road closed; and
- (5)** That the Petitioner be and is hereby directed to publish this Resolution in a qualified County newspaper once a week for three (3) successive weeks preceding the date herein fixed for public hearing on the Petition to close the portion of No Name 6 Road and to cause notice of the proposed closing and public hearing to be prominently posted in at least two (2) places along said portion of No Name 6 Road.

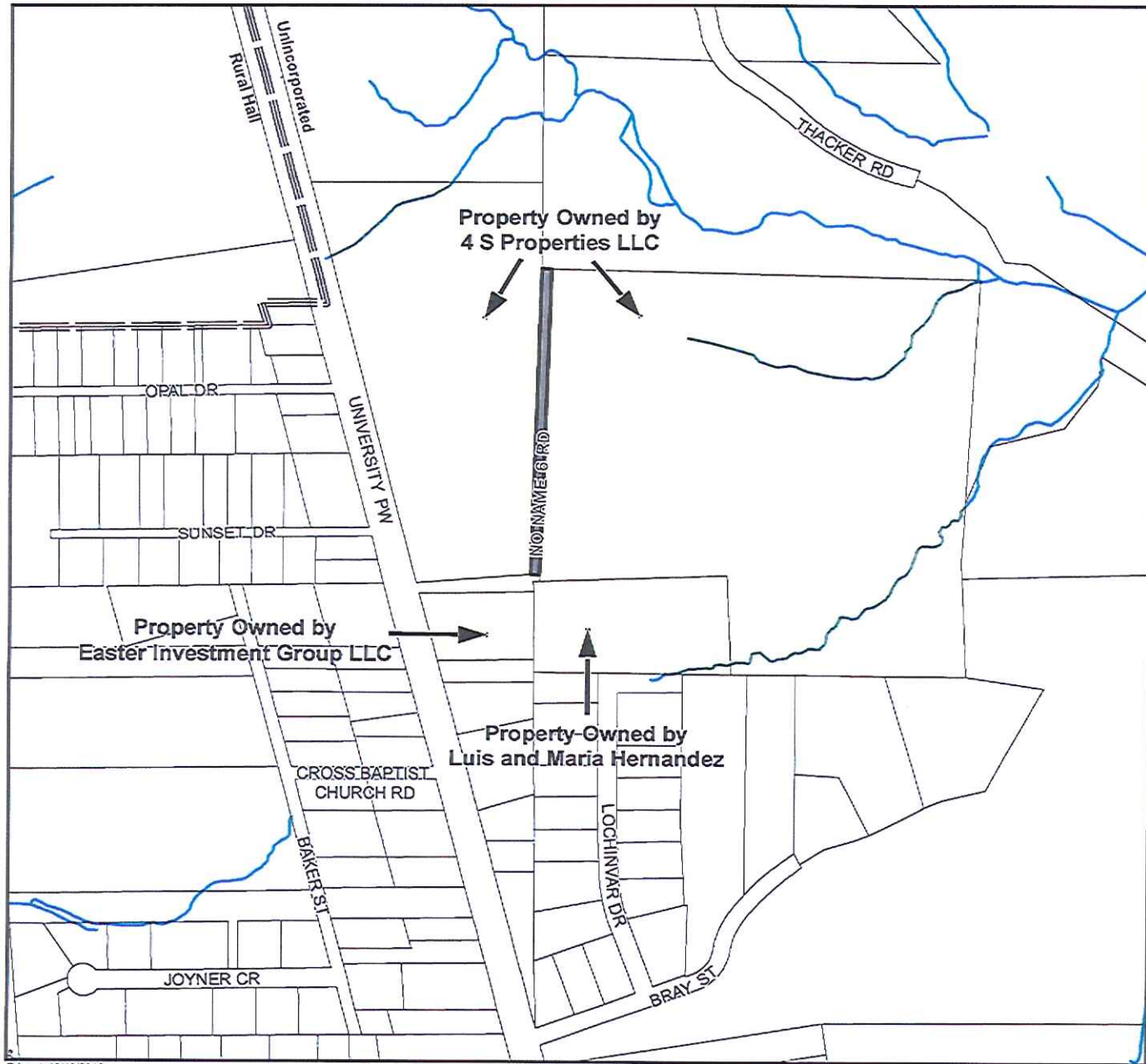


