COUNTY MANAGER'S RECOMMENDATION OR COMMENTS: Recommend Approval

SUMMARY OF INFORMATION:

On December 21, 2015, the Forsyth County Board of Commissioners adopted an amendment to the FY 2015-2016 Budget Ordinance to reserve \$2,500,000 for a possible building project at the Union Cross Business Park. These funds were made available from the Fiscal Year 2015 close of year-end through Financial Audit results as well as the fund balance policy change from 16% to 14% resulting in \$16,070,954 being available for debt avoidance, positive return on investment, capital projects, and or economic development projects.

On June 27, 2016, the Forsyth County Board of Commissioners adopted the 2016 New Family Museum Capital Projects Ordinance (CPO). This CPO was established through the potential sale of several county assets as well as the funds previously set aside for the building in Union Cross Business Park mentioned above.

While the agenda item on June 27, 2016 made the funds from the \$2,500,000 set aside for the building in the Union Cross Business Park available, the funds were never appropriated into the 2016 New Family Museum (Kaleideum) CPO. The Finance Department is requesting that the Board officially appropriate the \$2,500,000 that was reserved for the building at the Union Cross Business Park into the 2016 New Family Museum (Kaleideum) Capital Projects Ordinance.
