EXPLANATION:

On August 17, 2017, the Forsyth County Board of Commissioners adopted a Resolution authorizing execution of an interlocal agreement with the City/County Utility Commission for the development and construction of a regional sewer lift station serving Idols Road (Tanglewood) Business Park in conjunction with Davie County at a cost to Forsyth County of \$4,473,300.

The City/County Utilities Commission will own and operate the regional wastewater sewer lift station facility and be responsible for all future maintenance. The authorized agreement provides that Forsyth County will reimburse the City/County Utility Commission for the costs which include \$790,500 for engineering and design, \$71,000 for Clean Water State Revolving Loan Administration, and \$3,611,800 for construction.
