2018 MOTIVE EQUIPMENT REPLACEMENT CAPITAL PROJECTS ORDINANCE**

**EXPLANATION:**

This purpose of this request is twofold: 1. To appropriate insurance proceeds from a not-at-fault total loss motor vehicle accident to be distributed back to the 2018 Motive Equipment Replacement Capital Projects Ordinance for future vehicle purchases in the Sheriff's Office as follows:

\$ 9,047.40 – Sheriff's Office (2013 Dodge Charger-Vehicle 2523)

2. At the September 20, 2018 meeting of the Forsyth County Board of Commissioners, a resolution was approved declaring certain County motor vehicles and equipment surplus property and directing staff to dispose of the property by public auction. It is necessary to allocate the proceeds from the auction to the 2018 Motive Equipment Replacement Capital Projects Ordinance for future motor vehicle and equipment purchases by the departments listed below. The results of the auction are as follows:

\$ 19,775.00 - Fleet Management (Non-Emergency)  
 \$ 6,975.00 - Parks  
 \$ 31,775.00 - Sheriff  
\$ 8,000.00 - Emergency Services  
**\$ 66,525.00 - Total**

Within the 2018 Motive Equipment Replacement Capital Projects Ordinance, \$60,000 was already budgeted for the Sale of Autos. This item will appropriate the additional \$6,525 into the capital projects ordinance for future purchases.
