RESOLUTION AWARDING A CONTRACT TO ARAMARK CORRECTIONAL SERVICES, LLC FOR LAW ENFORCEMENT DETENTION CENTER (LEDC) ON-SITE FOOD SERVICES (FORSYTH COUNTY SHERIFF'S OFFICE)

SUMMARY OF INFORMATION:

On March 1, 2018, the Forsyth County Board of Commissioners, by unanimous vote, directed staff to obtain proposals from service providers for food services at the Detention Center.

A Request for Proposals (RFP) was issued July 16, 2018, a mandatory pre-bid conference and facility tour with interested bidders was held August 22, 2018, and proposals were received on September 21, 2018. Three (3) proposals were received.

Each proposal was assessed by an *intra-County staff team*, with assessors from the Detention Center, Sheriff's Office Administration, Budget & Management Department, General Services Facilities Division, as well as from the Forsyth County Health Department, Environmental Health Services Division (Food Health).

Proposals were reviewed and rated based on compliance with mandatory requirement(s) (attendance to the pre-bid conference), cost, past performance and experience, contractor's financial stability and condition, understanding of inmate food service regulations, staffing plan, food operations, menu, food safety and Officer Dining Room (ODR) plan. The individual assessment scores from each of the seven (7) assessors was consolidated into an average score. The highest possible score was sixty (60). A summary of the scores is shown in the table below:

County staff has determined that Aramark Correctional Services, LLC offered the best overall proposal and recommends that a contract for food services for the Law Enforcement Detention Center be awarded for an initial three-year period, with option to automatically renew for two additional years.

As specified in the RFP, the contract will be for an initial contract term of three (3) years commencing July 1, 2019, and ending June 30, 2022. Terms of the bid reserve the right for the County to automatically extend this Agreement for as many as two (2) additional twelve (12) month periods, ending June 30, 2024, provided that both parties are in agreement.

It is recommended by the County Manager, the Forsyth County Sheriff, and the Purchasing Director that a contract to provide on-site food services for the Law Enforcement Detention Center be awarded to Aramark Correctional Services, LLC.

The attached resolution awards the contract to Aramark Correctional Services, LLC in the amount of \$4,235,000, and authorizes the County Manager to execute any amendments necessary to continue services during the term of the agreement.

RESOLUTION AWARDING A CONTRACT TO ARAMARK CORRECTIONAL SERVICES, LLC FOR LAW ENFORCEMENT DETENTION CENTER (LEDC) ON-SITE FOOD SERVICES (FORSYTH COUNTY SHERIFF'S OFFICE)

WHEREAS proposals were received by the City/County Purchasing Department at 12:00 p.m. on the 21st day of September, 2018, to provide on-site food services for the Law Enforcement Detention Center from Trinity Services Group, Inc., Summit Food Services, L.L.C., and Aramark Correctional Services, LLC;

WHEREAS a team of County staff assessed the proposals based on a number of criterion including, compliance with mandatory requirements, cost, past performance and experience, food operations plan, Menu Plan, financial stability and condition, staffing plan, food safety plan and Officer Dining Room Plan;

WHEREAS Aramark Correctional Services, LLC was identified as the best overall proposal;

WHEREAS as specified in the RFP, the contract will be for an initial contract term of three (3) years, commencing July 1, 2019, and ending June 30, 2022, reserving the right for the County to extend this Agreement for as many as two (2) additional twelve (12) month periods, through June 30, 2024, provided that both parties are in agreement; and

WHEREAS it is the recommendation of the County Manager, the Sheriff, and the Purchasing Director that a contract for on-site food services be awarded to Aramark Correctional Services, LLC;

NOW, THEREFORE, BE IT RESOLVED, by the Forsyth County Board of Commissioners, that a contract to provide Detention Center food services is hereby awarded to Aramark Correctional Services, LLC in an amount not to exceed \$4,235,000, for the three-year period of July 1, 2019, and ending June 30, 2022, which contract will be automatically renewable for as many as two (2) additional twelve (12) month periods, through June 30, 2024, provided that both parties are in agreement, and that the County Manager and Clerk to the Board are hereby authorized to execute such a three-year contract with Aramark Correctional Services, LLC, with up to two twelve-month renewals, and to execute amendments thereto as necessary within budgeted appropriations, subject to a pre-audit certificate thereon by the Chief Financial Officer, if applicable, and approval as to form and legality by the County Attorney.
