## **Toby Bost Urban Tree Endowment Grant**

An Urban Tree Endowment Grant helps fund the planting and care of a tree on private or public property. It is a grant given to an individual citizen, group or organization within the Piedmont Triad. The recipient must reside in Forsyth, Stokes, Yadkin, Davie, Guilford, or Davidson counties. A recipient may receive up to a \$200 grant. Two grants will be awarded annually. To apply for the grant, please complete the below application. The application is due March 1.

## **Grant Criteria**

- 1. Applications are received January – February (March 1 deadline).**
- 2. Scholarship awards will be decided by the Toby Bost Urban Tree Endowment Fund Committee, appointed annually.**
- 3. The Fund Committee has the authority to approve up to \$150 in grant funds to any particular recipient.**
- 4. Grant recipients will be notified no later than March 15 by official letter of their award.**
- 5. Grant funds will be distributed to the recipients before April 15.**
- 6. The Committee will keep a record of grant recipients and their completed summary from their tree grant.**
- 7. Should 2 grants not be given annually, the funds will remain at NCSU Foundation, allowing the Committee to increase the number of possible recipients in subsequent years.**
- 7. If an applicant is of close relation (cousin, child, grandchild, sibling) or a business partner to a member of the Fund Committee, that member will not be allowed to vote due to conflict of interest.**
- 8. The grant will be allotted to applicants who receive a 2/3 vote of the Fund Committee.**
- 9. All recipients must be a resident of one of the following counties: Forsyth, Davie, Stokes, Guilford, Yadkin, or Davidson.**
- 10. Recipients must agree to plant, site, and provide appropriate care for the tree to ensure its survival; normally 18 months to 3 years.**
- 11. Inspection of the planting by an Extension master gardener volunteer, horticulturist, or tree care professional is encouraged but not required.**
