RESOLUTION APPOINTING JOHN T. BURGISS AS FORSYTH COUNTY TAX ASSESSOR/COLLECTOR

WHEREAS, John T. Burgiss meets all of the independent requirements and qualifications of N.C.G.S. 105-294(b) and has been certified for appointment as tax assessor/collector by the North Carolina Department of Revenue pursuant to the provisions of N.C.G.S. 105-294 and is therefore deemed to be qualified to serve as county tax assessor/collector; and

WHEREAS, in addition, Mr. Burgiss has during each 24 month period, since his last appointment as county tax assessor/collector, attended and successfully completed at least 30 hours of instruction in the appraisal or assessment of property as provided in regulations of the North Carolina Department of Revenue which qualify him to retain the position of county tax assessor/collector.

NOW THEREFORE BE IT RESOLVED, that pursuant to the authority provided by N.C.G.S. 105-294, the Forsyth County Board of Commissioners hereby appoints John T. Burgiss as Forsyth County Tax Assessor/Collector for a period of four (4) years, beginning July 1, 2013 and expiring June 30, 2017.

BE IT FURTHER RESOLVED, that the Forsyth County Board of Commissioners hereby determines the combined compensation of John T. Burgiss as Forsyth County Tax Assessor/Collector shall be \$3,552.00 per pay period.
