RESOLUTION AWARDING A CONTRACT FOR ROOF REPLACEMENT AT THE FORSYTH COUNTY LAW ENFORCEMENT DETENTION CENTER (GENERAL SERVICES DEPARTMENT)

COUNTY MANAGER'S RECOMMENDATION OR COMMENTS: Recommend Approval

SUMMARY OF INFORMATION:

Bids were received and publicly opened October 16, 2015, for the roof removal and replacement project at the Law Enforcement Detention Center. North Carolina General Statute (N.C.G.S.) 143-132(a) requires a minimum of three bids for formal construction and repair contracts, however fewer than three bids were received. Therefore, as required by N.C.G.S. 143-132(a) and 143-129, the project was re-advertised and bids were then opened on October 23, 2015.

The scope of work involves the complete removal of nearly 63,000 sq. ft. of existing single-ply membrane roof materials, insulation, and vapor barrier down to the concrete roof decks on all three levels, which were applied during the original building construction in 1992, and replacement with a new material composed of a vapor barrier membrane, lightweight insulating concrete, tapered to slope to the existing roof drains and openings, and a SBS modified bitumen roof membrane system which will carry a twenty-five year warranty.

In addition to the base bid amount add alternates were received as follows:

Alternate BC-1: Repair or replace existing cracked brick

Alternate BP-1: Brick tucking and pointing

Alternate B&S-1: Remove and replace building expansion joint sealant and backer rod

Alternate IG-1: Provide ice guards on upper standing seam roof

Alternate LA-1: Remove existing copper arrestor system

Alternate LA-2: Provide a new all aluminum lighting arrestor system

Alternate PT-1: Scrape, clean, prepare and paint the lower roof screen structural members

Alternate RE-1: Existing roof system materials removal and recycling

Alternate VE-1: In place of Parafor 30, apply aluminum faced Veral flashing

It is recommended by the County Manager, General Services Director, and the Purchasing Director that the base bid in the amount of \$1,943,154, and add alternates nos. BC-1, BP-1, B&S-1, IG-1, LA-1, LA-2, and alternate PT-1 in the total amount of \$73,275 be accepted and a contract for this work be awarded to Triad Roofing Company, Inc., in the total amount of \$2,016,429. This amount is less than the project estimate of \$2,250,000.

As a component of its documentation, an affidavit was submitted by Triad Roofing Company, Inc., committing to 10% M/WBE subcontractor participation for this work.

It is further recommended that the County Manager be authorized to sign change orders up to an amount not to exceed \$100,000 upon written agreement with the contractor and the surety on the bond specifying the additional or different work undertaken.

WHEREAS, it is the recommendation of the County Manager, General Services Director, and the Purchasing Director that the base bid in the amount of \$1,943,154, and add alternates nos. BC-1, BP-1, B&S-1, IG-1, LA-1, LA-2, and PT-1 in the total amount of \$73,275 be accepted and a contract for this work be awarded to Triad Roofing Company, Inc., in the total amount of \$2,016,429; and

WHEREAS, the County Chief Financial Officer has determined that sufficient funds are available to cover the cost of this contract.

NOW, THEREFORE, BE IT RESOLVED by the Forsyth County Board of Commissioners, that a contract for the roof removal and replacement project at the Law Enforcement Detention Center in the base bid amount of \$1,943,154, and add alternates nos. BC-1, BP-1, B&S-1, IG-1, LA-1, LA-2, and PT-1 in the total amount of \$73,275 be accepted and a contract for this work be awarded to Triad Roofing Company, Inc., in the total amount of \$2,016,429.

BE IT FURTHER RESOLVED that the County Manager and Clerk to the Board are hereby authorized to execute a contract, on behalf of Forsyth County, with Triad Roofing Company, Inc., for the roof removal and replacement project at the Law Enforcement Detention Center in the total amount of \$2,016,429, subject to a pre-audit certificate thereon by the Chief Financial Officer, if applicable, and approval as to form and legality by the County Attorney.

BE IT FURTHER RESOLVED that Triad Roofing Company, Inc., will be required to subcontract with minority owned businesses in the amount of 10% as indicated on its Affidavit.

BE IT FURTHER RESOLVED that all other bids are hereby rejected.
